Minutes of the Meeting of the Parish Council held on Tuesday 16 April 2019 at 7pm at Eccleston

184 Prayers: The Chairman welcomed everyone and opened the meeting with prayers for the work of the Council.

185 Apologies: Councillor W Ashcroft

186 Declarations of Interest: No declarations were made.

187 Parish Matters: (a) Cllr Barton reported that bollards had been installed at the bus stop at Coronation Road which caused a reduction in parking spaces. **Agreed the Clerk would contact St Helens Council to request a site visit to look at parking at the junction with Kiln Lane.**

(b) Cllr Greatorex reported that on 6 April 2019 he and Cllr Bate along with a resident of Rainford Road visited Windle Ward Councillors' surgery and met with Cllr Baines to express concerns for the safe exit of the Rainford Road cul de sac at Windle Island. The residents previously had to cross 2 lanes to turn right towards St Helens. They now had to cross 5 lanes. A meeting had then been arranged with Mr Walsh, St Helens Council's Engineering Department, Cllr Baines and the residents to discuss the issue of crossing 5 lanes towards St Helens. Mr Walsh explained that it may need to go to arbitration to get a box junction/keep clear sign installed. Another issue was that the grass verge had been reduced causing a problem for one resident exiting his driveway. Mr Walsh requested that a letter be sent by residents to St Helens Council, Engineering Department detailing the problems. Cllr Greatorex presented a copy of the letter to Parish Councillors for information.

(c) Cllr Dockerty mentioned a letter that had been published in St Helens Star newspaper reporting that signage painted on the road at Windle Island was incorrect. An incorrect road number was painted on the lane from Rainford to Liverpool.

Bleak Hill School

Single storey extension to existing school hall to west elevation and associated reconfiguration of playground area **The Parish Council objects to the expansion because of the increase in traffic and car parking. What consideration has been given to coping with the increase in traffic?**

The plans are not clear but the Parish Council query the siting of the new playground. If it is being pushed nearer to the road, there are concerns that it is nearer to pollution.

Can there be a guarantee that no trees will be felled without being replaced?

Demolition of existing single storey rear extension and conservatory and erection of porch to front and new flat roof single storey rear extension

32 Moss Lane

Demolition of existing conservatory to rear and the erection of single storey rear extension
